**TAFIS Email Notification**

**Bandar Seri Begawan, Brunei Darussalam (March 2015)** – Treasury Department, Ministry of Finance in collaboration with BAG Networks is pleased to announce that **TAFIS E-mail Notification** for Invoice submission and processing has been successfully implemented as of February 2015.

The main objective of introducing TAFIS E-mail Notification is to provide more accountability among the processors and greater transparency to the recipients on the payment status which aim to improve the efficiency and effectiveness of the government payment processes. Upon registering the email addresses, vendors will be notified via email the status of the invoices from submission to payment.

Currently all government agencies have allocated Invoice Receiving Counters where vendors are able to submit their invoices and a “**Notification Slip**” will be provided upon submission. Vendors are urged to ensure that the “Notification Slip” is received for every invoice submitted at the relevant departments which serves as a reference for enquiring payment status and proof of invoice submission.

For vendors to receive E-mail Notifications on the status of the invoices, Treasury Department call upon all interested vendors to fill up **Vendor Contact Form** to update vendor’s profile details by downloading it from Ministry of Finance website [[www.mof.gov.bn](http://www.mof.gov.bn)] and to be submitted to Treasury Department via E-mail as stated below:
