WHY IS IT IMPORTANT IN CHOOSING YOUR NAME?

A BUSINESS NAME is important because it provides a unique identity for your business and to differentiate it from your competitors. To have the business name exclusively yours, you can either register it under the BUSINESS NAMES ACT (CHAPTER 92) as a Sole Proprietorship / Partnership, or under the Companies Act (Chapter 39) as a Company.

HOW TO CHOOSE A NAME FOR YOUR BUSINESS?

When choosing a business name, keep the following tips in mind

Do's:

- Choose the right name that will help create the right image for your business.
- The business name should reinforce the key elements in your nature of business.
- Assist the Registry by providing the meaning of your applied name (in English or Malay) if you have applied for name in a different language.

Don'ts :

- Submit names that are identical to the names and / or resembles names that are already registered under the Business Names Act or Companies Act.
- Submit names that do not have any meaning that can mislead the public as to the nature of its business.

The proposed name also SHOULD NOT contain any of the followings:

- Undesirable names
- The words "Royal", "Diraja" or any name that may suggest the patronage of the Sultan or connection with the Government of Brunei
- The word "Brunei", "Co-operative", "Savings" or "Trust / Trustee"


Please note that the registration of business name may be referred to the Relevant Licensing Authorities for their approval depending on the business nature applied. For more information, please refer to the table below:

HOW DO YOU CHECK THE AVAILABILITY OF A NAME ?

Before applying for a business name, check existing names to determine if your proposed business name is available. By doing so, you have a higher chance of getting the name approved and reduce the risk of complaints against your business entity's name.

To check the availability of your proposed business name, conduct a business name search with these steps :



The following are examples of when you want to do a thorough and comprehensive name search :

FREQUENTLY ASKED QUESTIONS

Can I apply for a business name which is identical / has the same meaning with a business that is already registered in the Registry?

No. The business name applied will be rejected. You may have the option to write to the owner of the existing business for consent to use the same name or you may submit a new application with a different name.

How long does it take for a name to be approved?

2 working days.

Can I reserve 2 similar names for my new business as I have not decided on which name to use?

No, only a single name per application.

Can I reserve a name which is a trademark?

You cannot use a name that is trademarked, unless you provide an authorisation letter from the said company holding a trademark.

How long is the name reserved for? Can I get an extension?

Name Reservation will be 30 days. You are able to get an extension by maintaining Name Reservation for 60 days. However, the extension of name reservation is only applicable for Companies.
